Memorandum of Understanding **Health Post Renovation Project in Nepal** **among** **World Without Suffering Organization Nepal** **and** **Taiwan Alliance in International Development**

This MOU is made and entered into force upon by and among:

World Without Suffering Organization Nepal, (hereinafter “**WWSO Nepal**”), organized and existing under Nepali laws, located at GAIRIDHARA KATHMANDU METROPOLITAN, WARD NO.2, Nepal, represented by Chairman Mr. Satya Maan Lama.

Taiwan Alliance in International Development (hereinafter “**Taiwan AID**”), Taiwan, organized and existing under Taiwanese laws, located at R708, 7F, No. 54, Sec. 4, Mingsheng E. Rd., Taipei, 10574, Taiwan, represented by Chair Rebecca King-ying Wang.

1. PURPOSE

A magnitude 7.8 earthquake hit Nepal on April 25th, 2015 caused 3300 building was damaged and 8 million people were suffered from the disaster. Saramthali and Thuloparcel in Kavreplanchok district, located in central region of Nepal, are severally damaged in the earthquake. To facilitate the reconstruction of the two communities, Taiwan AID and WWSO Nepal are working together to initiate “Health Post Renovation Project in Nepal” for two health posts equipped with solar panels for local health service and education. The project will provide basic and comprehensive service to improve medical standard in the communities.

2. Goals and Benefits

The project is to repair two health posts in Saramthali and Thuloparcel, including: reinforcing beams structures, reinforcing shear walls, repairing walls, replacing roof (including leak hunting), equipping solar panels, deploying a electric system, replacing medical equipments and related facilities. Thuloparcel health post will benefit 6,500 local people and Saramthali health post will benefit 4,000 people every year respectively.

3. **Building location:** Saramthali and Thuloparcel in Kavreplanchok region

4. Building design

- Thuloparcel** health post: 18m*6m, RCC 1.5-floor building with tin roof provide basic health service for 6,500 people in Thuloparcel and neighboring area every year.
- Saramthali** health post: 15m*6m, RCC 1-floor building with tin roof provide basic health service for 4,000 people in Saramthali and neighboring area every year.

5. Timeline

The project timeline will be 1 year. The two health posts repairment will start in 2016. The plan, design and implementation of the project are estimated to be completed by January of 2017. The two health posts are projected to open and begin operation by January of 2017.

6. Funding

- A total number of NT\$ 1,700,000 (US\$ 51,515; 1 US\$: 33 NT\$)funding to WWSO Nepal includes:
 - An advance payment of 50% (US\$ 25,758) following the signing of this MOU.
 - A second payment of 40% (US\$ 20,606) upon WWSO Nepal's submission of the mid-term report.
 - A final payment of 10% (US\$ 5,151) after the repairment completion and submission of final report.
- The remaining fund should be remitted back to the account of Taiwan AID.

- vi. The fund can be used only for the repairment of the two health posts, local transportation and installation of medical facilities and solar panel. The fund amount shall be all-inclusive, with no additional reimbursement of any other expense unless agreed in advance by Taiwan AID in writing.
- vii. All funding under this MOU is provided in good faith and is intended solely for the specified purpose. The diversion of funds for any other purpose without the prior written approval is expressly forbidden.

7. OBLIGATIONS OF THE PARTIES

The Parties intend to maintain an open, collaborative, and cooperative working relationship, agree to the following areas of responsibilities:

Taiwan AID

- i. Take responsibility of monitoring, evaluation and quality control of the entire construction process with sponsors and relevant professional organizations.
- ii. Take responsibility of budget control
- iii. Provide 1,700,000 NT\$ remitted to WWSO Nepal as project fund.
- iv. Take documentary film.

WWSO Nepal

- i. Oversee the overall operation of the project.

- ii. Take responsibility of all license application and related administrative requirement from the government of Nepal.
- iii. Provide reports to Taiwan AID, including:
 - 1). Quarterly report: submitted at every three months; contains description of repairment progress and photos
 - 2). Mid-term report: submitted at the 50% completion of the repairment; contains description of repairment progress, photos, and future schedule of repairment.
 - 3). Final report: submitted within 1 month of the completion of construction; contains statement of income and expenditure
- iv. Assist with customs clearance and local logistics for solar panel and relative equipments.
- v. Assist project site visit for documentary film.
- vi. Provide best quality materiel and medical facilities following the project goals and budget.
- vii. Provide original receipts to Taiwan AID once receiving the first payment of fund.

8. PUBLIC PROMOTIONS

- i. A nameplate of Taiwan AID should be hanged on the conspicuous place on the two health posts. Opening ceremonies of the two health posts are required and should invite all related NGOs and donors.
- ii. Media report and public promotion event are required and show love from Taiwan, friendship between Taiwan and Nepal.
- iii. For any promotional events, the Parties acknowledge prior approval on the use of one another's official names or logos.

9. AMENDMENT AND TERMINATION

This MOU is not to be amended or modified except it is based on the result of the meeting held by the Parties.

10. PROJECT EXTENSION

Force majeure (e.g. natural disasters) occurs during the Project implementation and inhibits the Parties from fulfilling the obligations under the MOU. In accordance with the approval of the Parties, it shall be an extension for the Project completion. However, if the extension is caused without any force majeure, WWSO Nepal should cover all additional costs of the extension work.

11. DISPUTE SETTLEMENT

This MOU shall enter into effect upon the signature of the Parties. Any disputes arising from the execution of or in connection with this MOU shall be resolved through negotiations in the spirit of partnership. If a resolution cannot be reached, the Parties may take the matter to an appropriate independent arbiter, which is situated in Taiwan and has the jurisdiction for the main arbitration. The cost of arbitration shall be borne by the losing Party.
